## RELEASE OF ALL CLAIMS

In consideration of participating in "Medford Cruise 2011" and all related events (hereinafter the Medford Cruise) in Jackson County, Oregon, the undersigned and his/her heirs, executors, administrators, and assigns hereby release, waive, discharge and relinquish any action, claim or cause of action which may hereinafter arise from the undersigned's participation in said "Medford Cruise". The undersigned and the heirs of his/her estate agree that under no circumstances will he/she or his/her heirs, executors, administrators, and assigns prosecute, present, or pursue any claim for personal injury, property damage, or wrongful death against the Medford Cruise Association, or Board of Directors of the Medford Cruise Association, including all of the aforementioned owners, officers, employees, volunteers or participants in said Medford Cruise, for any cause of actions, whether or not it shall arise from the negligence of any person out of the undersigned's participation in/or view of the recreational activities being conducted.

The undersigned hereby acknowledges that the Medford Cruise Association and the Board of Directors of the Medford Cruise Association have made these events open for the use of the undersigned to participate in and/or view a recreational activity and that the undersigned understands the risks inherent to these events and the injuries which may result therefrom.
